TOWN OF MILLINOCKET REQUEST FOR BUILDING DEMOLITION BIDS

The Town of Millinocket is currently accepting bids for the demolition of buildings on Town owned property located at 75 York Street and 81 York Street in Millinocket.

The successful bidder must remove all buildings, contents, if any, and lot improvements from each lot, sort and appropriately dispose of all demolition debris and other material removed from the lots, level the foundation, and backfill the foundation hole with clean gravel such that the surface of each lot is level with the adjacent street and is free from safety hazards. The successful bidder is entitled to all salvage value of the material removed from the lots. The foundation hole may not be filled with debris or material from the buildings to be removed or any other source.

All work must be performed between the hours of 7am and 8pm and all work must be completed by July 23, 2018, at 5pm. All work must be done on the lots owned by the Town and the successful bidder may not encroach onto adjacent property without the permission of the landowner. All work must be done in accordance with all applicable state, federal and/or Town laws, regulations, and ordinances. Each work site must be secured to prevent injury to members of public, including passersby and individuals on the work site without permission, when workers are not on site.

The successful bidder must indemnify the Town against all loss as a result of the work and must provide proof of liability (\$1,000,000) insurance and workers compensation insurance at the time the bid is awarded. The Town must be added as an additional insured to the contractor's liability policy for the term of the work and a certificate of such insurance must be provided to the Town before work starts..

The successful bidder must obtain a demolition permit from the Millinocket Code Enforcement Officer prior to commencing work.

Bids are to be placed in a sealed envelope and marked "Bids for demolition of York Street Properties" and mailed or delivered to the Millinocket Town Office, 197 Penobscot Avenue Millinocket, Maine 04462, on or before Wednesday, May 23, 2018 at 3:00 p.m.

Appointments to inspect the buildings may be made by calling Ralph Soucier, Public Works Director, at 723-7030, or John Davis, Town Manager, at 723-7000. Mr. Saucier shall monitor the work on behalf of the Town. Payment for work will be made upon completion of the work and inspection by Mr. Saucier.

Bids will be opened by the Town Manager on May 23, 2018 at 3pm. Bidders may attend. The successful bid will be awarded by the Millinocket Town Council on the May 24, 2018 Town Council meeting. The Town reserves the right, in its sole discretion, to reject any and all bids, to determine whether bidders are qualified and to award the bid on a

basis other than the lowest price. In the event the successful bidder withdraws, the Town may award the bid to another bidder or solicit new bids for the work.
