Dear Jody:

I am working with Katahdin Area Trails on an RTP grant due in on Sept 27th. The Grant would cover 1 mile plus of purpose built, single track mountain bike trails on the golf course land adjacent to the ball fields. I spoke to Doug Beck last week and he mentioned that I should contact you and have you reach out to him about a potential change in use/additional use type for the land that is governed by the grant funding received from the State for the Ball fields.

My understanding is that he would just need an email from you stating that this work might happen and mountain biking/hiking may be an additional use and then he would write back to you confirming the change/additional use.

We have spoken with the town of Millinocket, I did email the superintendent a few weeks back and have not heard from them, we are getting permits from the golf course and our katahdin and we have spoken with the timber cruisers regarding access via the snowmobile/atv/multiuse trail.

I am attaching a map we have prepared for the golf course showing the possible location of the 1mile+ of trail but the trail is not actually designed yet and there are a number of additional steps that would need to be covered. We would plan on having the International Mountain Bike Association design the trails and we would plan on having them built by Katahdin Area Trails with a local trail crew and also Maine Conservation Corps.


Please let me know that you received this and if you feel comfortable reaching out to Doug on this topic.
