Subject: Funding to make voting easier in your municipality

Greetings~

This note is to let you know about funding for municipal projects to make it easier for people to vote during the upcoming election. Unfortunately, the funding is competitive so, to have a good chance to get the funds, municipal officials need to apply next week, starting September 08.

Now, for some background....

The Center for Tech and Civic Life (CTCL) has received a large grant from Chan-Zuckerberg initiative to expand its support of election administrators in 2020. CTCL is a 501(c)(3) whose board and advisors include Republican, Democratic, and unaffiliated election officials from across the country. Thanks to this expanded funding, CTCL is launching an online portal where any election administrator in America can apply for funding to help cover the cost of executing their country's or municipality's election: tech and civic life.org/grants.

Election offices can use the funds to cover 2020 expenses, including the following:

# Ensure Safe, Efficient Election Day Administration

- Maintain open in-person polling places on Election Day
- Procure Personal Protective Equipment (PPE) and personal disinfectant to protect election officials and voters from COVID-19
- Support and expand drive-thru voting, including the purchase of additional signage, tents, traffic control, walkie-talkies, and safety measures

## **Expand Voter Education & Outreach Efforts**

- Publish reminders for voters to verify and update their address, or other voter registration information, prior to the election
- Educate voters on safe voting policies and procedures

### Launch Poll Worker Recruitment, Training & Safety Efforts

- Recruit and hire a sufficient number of poll workers and inspectors to ensure polling places are properly staffed, utilizing hazard pay where required
- Provide voting facilities with funds to compensate for increased site cleaning and sanitization costs
- Deliver updated training for current and new poll workers administering elections in the midst of pandemic

## Support Early In-Person Voting and Vote by Mail

- Expand or maintain the number of in-person early voting sites
- Deploy additional staff and/or technology improvements to expedite and improve mail ballot processing

Your town should have received notification about these grant funds through the Maine Municipal Association, but, we wanted to make sure that the word gets out as broadly as possible.

#### ORDER #219-2020

#### PROVIDING FOR: APPROVAL OF LOAN COMMITMENT

WHEREAS, the Town financed a portion of the redevelopment of the former Stearns High School into subsidized housing for the elderly and disabled and congregate housing; and

WHEREAS, the Town holds a Promissory Note from Stearns Assisted Housing Associates, L.P., in the amount of \$260,500; and

WHEREAS, The Town's Note is secured by a mortgage deed on the Stearns Assisted Living portion of the project and the Town's mortgage lien is subordinate to the mortgage interest of the Maine State Housing Authority; and

WHEREAS, JMC Partners, LLC, proposes to acquire the Stearns Assisted Living portion of the project and to add 25 subsidized units to that project; and

WHEREAS, JMC Partners, LLC, has asked that the Town agree to continue its financing of Stearns Assisted Living component of the project.

## NOW THEREFORE,

IT IS ORDERED that the Town continue its financing of the Stearns Assisted Living project on the same terms and conditions as the original loan to Stearns Assisted Housing Associates, L.P.;

IT IS FURTHER ORDERED that the Town Manager is authorized and directed to execute and deliver the loan commitment letter attached to this Order; and

IT IS FURTHER ORDERED that the Town Manager is authorized to take all action necessary to complete the loan transaction including cancelling the Note from Stearns Assisted Housing Associates, L.P., upon receipt of payment, discharging the mortgage from Stearns Assisted Housing Associates, L.P. and accepting a new note from JMC Partners, LLC, accepting a new mortgage from JMC Partners, LLC, and subordinating that loan and mortgage to the mortgage lien of the Maine State Housing Authority.

IT IS FURTHER ORDERED that the financing authorized by this Order replaces and supersedes the financing for the same project authorized by Order #191-2019.
