If you are 60 years or older, a school staff member, or a licensed childcare provider then you are currently eligible to receive the COVID-19 vaccine.

#### Important information about scheduling your vaccination:

- Vaccine Appointment Slots will be limited: At this time the supply of vaccine in the state of Maine is very limited. We will open appointments as we receive vaccine.
- You must register to receive the vaccine. Vaccinations must be scheduled due to the fragility and logistics of reconstituting these vaccines. This also ensures that we have vaccine available and we can schedule your second dose on time.
- You must be 60 years of age or older, a school staff member, or a licensed childcare provider to be vaccinated at this time. Please bring some form of identification confirming your age or employment with you to the vaccination clinic.
- Please print your appointment confirmation and bring it with you. Vaccination candidates will receive an email confirming their vaccination location and time. If they do not see this email, they should check their spam folder.
- If you have insurance information, please bring it with you. The state of Maine is unable to cover the cost of administration of the vaccine at this time. Because of this we need to bill your insurance provider to help staff the vaccination clinics. The vaccine itself is provided at no cost.
- If you are unable to make your vaccination appointment, please use the cancellation link in your confirmation email to free up that time for another person.
- If no appointments appear as available, please know that appointments are added as soon as have confirmation of
  vaccine shipment, this prevents the risk of scheduling appointments that may not have vaccine available.
  Appointments are added every week on Monday.

#### Make sure you have the following information ready to schedule your appointment:

- Contact Information Information for a next of kin or other emergency contact.
- Insurance Card If you have insurance, bring your card along with you.

#### Information on free ride program through DHHS

Individuals must have a vaccination appointment before requesting a ride. Rides will be provided to and from the appointment. These may be shared rides so DHHS can provide transportation to as many people as possible, and face masks will be required.

DHHS can provide transportation for appointments that are scheduled Monday through Saturday from 7:00 am - 4:00 pm. At least 48 hours before the vaccine appointment, individuals should call **1-855-608-5172** to reserve a ride and should have the following information ready:

- Date and time of appointment
- Name, address, and phone number of the facility where they are receiving the vaccination.

MaineCare members who already use a Non-Emergency Transportation broker to arrange rides to their MaineCare-covered services should call that same broker for rides to vaccination clinics. This program is for MaineCare members who are ineligible for Non-Emergency Transportation as well as any other Maine resident who does not have access to reliable transportation to get to their vaccination appointment.
