To Property Owners and Residents,

We hope this letter finds you well. We are writing to address a series of recent complaints. The area of concern is the unoccupied open field (Map U03-171) along Highland Avenue which is owned by The Town of Millinocket.

Signs are posted along the side of the road next to the field stating "No Parking on Grass". Parking on the grass is prohibited. Anyone found parking there is subject to a parking ticket and possible fees or fines that may arise to repair any damages to the property.

Town of Millinocket does not give permission to plow snow onto this property. As stated in Chapter 108-2 in the Millinocket Code book, "Snow removed from driveways shall be stored within the boundaries of the premises from which it is removed and shall not be plowed or deposited in the area reserved for street or sidewalk purposes." Furthermore, plowing across a roadway is prohibited under state law.

We hope this message is found to be informative and helpful. Our goal is solely to educate and alleviate any future concerns or friction between the Town as a municipality and our community members. If you have any questions, please feel free to contact myself or the Town Manager. We are always willing to listen and help where we can.
