## Millinocket Farmers' and Artisan Market Info Sheet

The Season is each Saturday, June 3- Sept 16 from 9am-12pm and will be held at Veterans Memorial Park, 50 Penobscot Avenue, Millinocket. Featuring **ONLY** Mainegrown produce/products, or handcrafted artisan items, coffee, and music.

## To participate in the Millinocket Farmers' and Artisan Market you must:

1. <u>Obtain relevant Town of Millinocket Permits.</u> Vendors wishing to sell meat, cheese, milk, prepared/value added foods must comply with all appropriate state and federal laws, hold valid and current licensing permits and insurance.

To be a vendor in the Town of Millinocket, you must obtain:

- A Victualer's License is required for any entity preparing, selling, or serving food. Fee is \$25.00 annually with a mandatory May expiration. (Note: this process can take up to 2 weeks or longer for approval).
  or
- A **Peddler's License** is required for homemade, homegrown, from the ocean or from the sea. Fee is \$15.00 annually.

These permit applications are available at the Town Office. This information is also found on the town website: <u>www.millinocket.org</u> under Business and Permits/ Licensing. Licensing fees must be paid at the Town Office in the Municipal Building in Millinocket at 197 Penobscot Ave.

## 2. <u>Fill out the Farmers' Market Application and submit application with the</u> <u>vendor fee to the Town of Millinocket.</u>

- 1) Payment of vendor fee MUST be included with the application.
  - a. Vendor fee for the entire 2023 season is \$40.00.
  - b. The other option is to pay a fee of \$10 per each market no later than the Friday before that upcoming Saturday Market.
  - c. All fees MUST be paid by Friday, 4:00pm, prior to participating at the Market.

Checks should be made out to Town of Millinocket, memo line 'Farmers' Market fee'.

Vendor fees can be paid by phone by calling the Clerk's office at 723-7006/7007.

 If paying by phone, be sure to mail your Market application to: Town of Millinocket, 197 Penobscot Avenue, Millinocket, Maine 04426 Or fax it to 207-723-7002 or email it to: <u>townclerk@millinocket.org</u>

Remember: To participate you need proof of the proper Town permits, a submitted application along with vendor fees paid to the Town.
