Lisa, CEO of Wabanaki Health, provided an overview of Wabanaki's services, mission and purpose, healing and family support.

Michelle Anderson - expressed full support of the project and its importance to the community.

Heidi expressed the same sentiments.

Public hearing:

Tim Smythe Lincoln Street - Expressed concern about public safety and teh populous that the center will house.

Lisa Responds: It is a house with 9 people at any given time. THey have no reason to expect any issues. The group has several homes that are run in the same way, and have never had any type of public safety issues. Staff is present at all times.

Peggi Cumming, bordering neighbor - Questions who is served

Lisa Responds - not just the Wabanaki, all community members are served.

Peggi Cumming - greatest concern is on the property state (current) wants to better clean up of weeds and the tar area, and pushed for a date for project completion.

Tom Wabanaki representative - states working to get grant review, putting out to bid in next two weeks. Projected start in Winter of 2025

Peggi Cumming - 2nd greatest concern is the mouse population that has increased, requested a contingency for rodent issues (unknown)

Board will not make a decision on this issue

Charles, community member - supports the initiative, lives adjacent to another recovery center and states it's the best thing for his neighborhood.

Bryan Lawrence - abutting neighbor, has run a similar program with great results and fully advocates for this program.

Peter Jamison - community member fully supports the program, you never know who will need this, a value add to the community.

Stacy Smith - abutting neighbor, concerned about landscaping issues

Emily responds with a review of the landscaping plans, adding additional trees as a buffer

Lisa impresses her understanding of timelines, and expresses sentiment that the project is moving forward.

Tim - Community member, questions whos paying for the program

Lisa responds with federal grants and donor, no Millinocket tax dollars will fund this project.
